#### **Spotlight on Warren**

With the completion of a our City Hall, Library, and two-acre City Square, Warren's newly created downtown has become the heart of our community. A soaring five-story glass enclosed atrium topped by a dramatic cantilevered roof reaches out to the concert lawn and green spaces of the Square. At the Square's entrance stands Dawn, the stainless steel sculptures that herald our community's new era. Surrounding Dawn is our innovative combined skating rink and water feature that draws residents and visitors alike year round. Finally, a new street pattern around the Civic Center is taking shape with the construction of 18 blocks of streetscape in authentic urban style. It is a galvanizing start that has created a truly 21st Century urban experience.


